**ORDER No. ES3-36758/2015/DHS dated 12/05/2016**

As per order read 1<sup>st</sup>, the final seniority list of Staff Nurse Grade-II for the period from 01/01/1978 to 06/07/1990 in this Department was published. The promotions to the cadre of Staff Nurse Grade-I effected from the said seniority list was reviewed with effect from 01/11/1999 and the final seniority list of Staff Nurse Grade-I as on 01/11/1999 was published vide order read 2<sup>nd</sup>. The subsequent seniority list of Staff Nurse Grade-II for the period from 07/07/1990 to 31/12/2002 was published vide order read 3<sup>rd</sup>. The incumbents bearing rank no. 1 to 3459 in the seniority list read 3<sup>rd</sup> was promoted to the cadre of Staff Nurse Gr-I vide order read 4<sup>th</sup>. Those incumbents who were on leave without allowances during the period were promoted vide subsequent orders after their rejoining.

As per circular read 5<sup>th</sup>, the service particulars of the incumbents who were promoted to the cadre of Staff Nurse Gr-I from 10/11/2008 to 20/08/2013 were called for in connection with preparation of seniority list. The details received in this regard from all District Medical Officers have been compiled and the preliminary seniority list of Staff Nurse Gr-I for the period from 10/11/2008 to 20/08/2013 is published herewith as detailed in **Annexure-A** appended. In respect of the incumbents who joined as Staff Nurse Gr-I as per order read 4<sup>th</sup>, their seniority has been arranged in the order of their seniority position in the cadre of Staff Nurse Gr-II as per order read 3<sup>rd</sup>. In respect of the incumbents who rejoined duty after LWA between the period from 11/11/2008 to 20/08/2013, their seniority has been arranged with effect from the date of rejoining duty after LWA assigning the date of rejoining as eligible date for promotion.

The preliminary seniority list is published based on the staff position as on 31/12/2015 and those incumbents who were promoted vide order read 4<sup>th</sup> and those have already left this Department by opting Medical Education Service consequent on abolition of dual control system have been excluded.

Appeals if any regarding non-inclusion of name, correction in service particulars, anomaly in assigning seniority position etc shall be submitted through proper channel in the prescribed format appended as Annexure-B. Such appeals should be accompanied with proper supporting documents and should be submitted to this office **on or before 15/06/2016**. All District Medical Officers are requested to circulate the preliminary seniority list published in the official website of this Department to the subordinate institutions under their control.
