ORDER NO. ES3-12537/2015/DHS, DATED: 01/07/2016

As per the reference 1st to 4th cited, 4 Pharmacists have submitted representations to rectify the anomalies occurred in the seniority list of Pharmacist Gr.II from 1999-2008 and 2009-2013 published vide references 8th to 9th respectively. The points raised in their request have been examined in detail with all connected service details and found that their name has not been included in the respective seniority lists.

Sri.Rajeev.V.B, Pharmacist Gr-II, Primary Health Centre, Orumanayoor, Thrissur, had filed O.A 1305/2015 praying to include his name in the seniority list of Pharmacist Gr-II from 1978-1990. Based on the order of the Hon.Kerala Administrative Tribunal dated 18/12/2005 in O.A 1305/2015, it was decided to include him in the pre-revised seniority list of Pharmacist Gr-II from 1978-1990 published vide order referred 5th , after observing formalities.
