On verification of the Service Book of Smt.Shilaja.D, Junior Public Health Nurse Gr.I it is seen that she has entered in service has Junior Public Health Nurse Gr.II through PSC advice No.D6-635/1981/dtd.17/04/1993 KPSC, Kozhikode before the promotion of Junior Public Health Nurse Gr.I she had secured Inter District Transfer in the entry cadre from Kozhikode to Kottayam and joined at Kottayam on 31/05/1997.

She secured Inter District Transfer in the entry cadre and her seniority in the entry cadre were not lowered in the seniority list of Junior Public Health Nurse Gr.II and she was seen promoted to the cadre of Junior Health Nurse Gr.I on the basis of wrong seniority position.

Inter District Transfer of DRB recruiters upon request can be granted only under the terms and conditions stipulated in the G.O referred above. As per Rule 27 Part II of KSS&SR and G.O referred above, no Inter District Transfer is possible without for feather of accrued seniority in the old district and the transferee will be the junior most in the new district. Accordingly Smt.Shailaja.D who secured Inter District Transfer from her recruited gdistrict is eligible to be reckoned her seniority only with effete from the date of joining ie,

31/05/1997 in the transferred district. She is eligible to reckon her seniority only with effect from ie, 31/05/1997 the date of joining duly in the transferred district.

In this circumstances, it is provisionally decided to reassign the rank of Smt.Shailaja.D as 602 A instead of 3482 on the basis of Inter District Transfer she secured from Kozhikode to Kottayam on 31/05/1997.

Persons who are likely to be aggrieved by the above proposed may file appeal if any within 15 days from the date of issuance of this notice.
