ORDER

Dr.Sudheer.S vide representation read as 4th paper above requested for promotion to the post of Consultant as he has been excluded from the promotion order issued as per G.O read as 1st paper above. He has filed OA 600/2016 before the Kerala Administrative Tribunal for non consideration of Annexure A10 (his representation). In Annexure A10 of OA 600/2016, Dr.Sudheer.S requested to promote him and post in the open vacancy that occurred on the superannuation of Dr.Mohammed Ali.

2.The Hon'ble KAT in their order dated 5.9.2016 directed Government to hear the applicant and to take a decision on his request within 2months from the date of receipt of order.

3.The Director of Health Services as per letter read as 2nd paper above reported that the request of Dr.Sudheer.S for promotion as Consultant (Orthopaedics) can be considered only after the finalisation of disciplinary action initiated against him.

4.Accordingly, along with the representation of the medical officer, a personal hearing was conducted by the Deputy Secretary, H&FWD as ordered by the Hon'ble Kerala Administrative Tribunal. At the time of hearing Dr.Sudheer.S stated that after PG course he was not given any appointment order but he joined in General Hospital, Ernakulam. As per Rule 12 (7) of KSR, he reported to the original station and waited for the appointment order.

5. Government examined the matter in detail. Dr.Sudheer.S was on unauthorised absence from 29.8.2015 to 4.4.2016. So his name was not included in

the proposal sent to Government for granting temporary promotions to the post of Consultant. The disciplinary actions initiated against the medical officer is still pending. So he cannot be considered for promotion. Annexure A10 representation of the applicant is thus rejected and the judgment of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.


