Sub: Finance Department - House Building Advance - Extension of date for the submission of applications in respective offices by Government employees/ Teachers and online registration of applications by the Head of Department/ Sanctioning authority 2017-18- Modified circular issued reg:-

Government have reintroduced the House Building Advance Scheme to State Government Employees and Teachers as per G.O. cited 1st above. In pursuance of the above Government Order and the instruction contained in the circulars cited all Heads of Department and sanctioning authority are instructed to follow them before online registration of application. As per reference 5th cited, the time limit fixed for the submission of HBA applications in respective offices by Government Employees/ Teachers ended on 15/05/2017.

It has come to the notice of Government that applicants could not submit the application on time owing to the unavailability of documents from various offices.

Government have examined the matter in detail and are pleased to extend the date for the submission of HBA applications for the financial year 2017-18 is as follows


- The time for submission of applications in respective offices by Government Employees/Teachers -within 31/05/17.
- Time for furnishing applications to the Head of the Department by the respective offices- -within 15/06/17.
- Time for online registration of applications from the office of the Head of department starts on 16/06/2017 & ends on 15/07/2017 at 5 pm
- Time for furnishing of the Department wise eligibility list by the Head of the Department to Finance Department -within 25/07/17.

The Circular 5th cited above stands modified to this extent and all other instructions remains the same.


