ORDER NO. EA2- 68439/2017/DHS Dated 23.12.2017

Dr. Shabeeb.P.K, Assistant Surgeon applied for General Transfer 2017 but he was not included in the Final List published by this respondent dated 25.07.2017.

Aggrieved by this order he filed an OA No. 1540/17 before the Honourable Kerala Administrative Tribunal for getting transfer to Community Health Centre Urngattiri, Malappuram. The Honourable Tribunal in its order read 1st above directed the Director of Health Services to consider the Annexure A6 representation of the petitioner dated 27.07.2017 after affording a personal hearing to the applicant. In obedience to the above direction a personal hearing was conducted on 16.12.2017.

The Annexure A6 has examined in detail in the light of order Honourable Kerala Administrative Tribunal dated 07.08.2017 and it is found that the claim of the petitioner is genuine. Hence the following modifications are made in final order read as 4th cited.

Dr. Shabeeb.P.K, Assistant Surgeon, Primary Health Centre Ramanattukara, Kozhikode is transferred and posted to **Community Health Centre Urngattiri, Malappuram** district and Dr. Fazil.K, Assistant Surgeon, Primary Health Centre Urngattiri, Malappuram is transferred and posted to **District Hospital Nilambur, Malappuram as Casualty Medical Officer.**

The representation on the applicant is finalised as above and the direction of the Honourable Kerala Administrative Tribunal read 1st cited is complied accordingly.
