Hence, Smt. Jasmi James is promoted to the cadre of Pharmacist Store Keeper in the scale of pay Rs. 30700 - 65400 and posted to General Hospital Ernakulam as per Rule 31 (a) of KS&SSR.

The promotions are made purely on provisional basis considering exigencies and will be reviewed if necessary based on the final order of the Honourable Kerala

Administrative Tribunal in OA No.1271/2014. The promotee will be placed on probation for a period of one year of duty within a continuous period of two years from the date of joining duty.


