PROCEEDINGS OF THE ADDITIONAL DIRECTOR OF HEALTH SERVICES (A&T)

Sub: - Estt- HSD - Promotion to the cadre of Junior Health Inspectors Grade I- Smt. Sreeja S R, JHI Gr.II and Sri.Dilip T S, JHI Gr.II - orders issued.

As per this office order read 2nd above, Junior Health Inspectors Grade II were promoted to the cadre of Junior Health Inspectors Grade I. Rank No.166, Sri.Dilip T S had not acquired MPW Training and hence he excluded from the promotion list and as Rank No.586 Smt. Sreeja S R had availed Inter District Transfer to Kollam, she was also excluded from the promotion list. As per the order 3rd cited, all employees in the said order were granted retrospective effect of promotion with effect from 01.02.2011.

As per read 5th cited the DMO, Thiruvananthapuram has forwarded the application for promotion of Sri.Dilip T S, JHI Grade -II, PHC, Poozhanad along with the copy of his MPW Training Certificate. He completed the Training only on 13.09.2013. Therefore he is eligible for getting ratio promotion to the post of JHI Grade I with effect from 14.09.2013.

Smt. Sreeja S R was recruited through PSC Idukki and entered in service on 27.09.2002 and acquired MPW Training on 07/2008. Later she got Inter District Transfer to Kollam and joined duty at Kollam on 28.04.2011 before getting promotion to the post of JHI Grade I.

Consequent to the retrospective effect of promotion the juniors to Smt. Sreeja S R were promoted w.e.f 01.02.2011. Aggrieved by this she filed OA No.1264/2015 before the Hon'ble KAT. The Hon'ble Tribunal in order read 1st cited had directed this respondent to consider the claim of the applicant for ratio promotion as JHI grade -I w.e.f. 01.02.2011 based on her seniority as reflected in Annexure A3 seniority list within three months from the date of production of the order. The matter was examined in detail and it is found that Smt. Sreeja S R is eligible for promotion w.e.f. 01.02.2011. In circumstances the following Junior Health Inspectors Gr.II are promoted to the cadre of Junior Health Inspector Grade I and retained in same station as detailed below.
