**ORDER No. ES3-6911/2017/DHS dated, 16/04/2018**

The final seniority list of Staff Nurse Grade-I with effect from 10/11/2008 to 20/8/2013 was published vide order read as 1<sup>st</sup> above. As per circular read 5<sup>th</sup>, the service particulars of the incumbents who were promoted to the cadre of Staff Nurse Gr-I from 21/08/2013 to 31/12/2016 were called for in connection with preparation of seniority list. The details received in this regard from all District Medical Officers have been compiled and the preliminary seniority list of Staff Nurse Gr-I for the period from 21/08/2013 to 31/12/2016 is published herewith as detailed in **Annexure-A** appended. In respect of the incumbents who joined as Staff Nurse Gr-I as per order read 2<sup>nd</sup> to 4<sup>th</sup>, their seniority has been arranged in the order of their seniority position in the cadre of Staff Nurse Gr-II. In respect of the incumbents who rejoined duty after LWA between the period from 21/08/2013 to 31/12/2016, their seniority has been arranged with effect from the date of rejoining duty after LWA assigning the date of rejoining as eligible date for promotion.

The preliminary seniority list is published based on the staff position as on 01/01/2017 and those incumbents who were promoted vide order read 2<sup>nd</sup> to 4<sup>th</sup> and those who have already left this Department by opting Medical Education Department consequent on abolition of dual control system have been excluded.

Appeals if any regarding non-inclusion of name, correction in service particulars, anomaly in assigning seniority position etc shall be submitted through proper channel in the prescribed format appended as Annexure-B. Such appeals should be accompanied with proper supporting documents and should be submitted to this office **on or before 30/04/2018**. All District Medical Officers are requested to circulate the preliminary seniority list published in the official website of this Department to the subordinate institutions under their control.
