If any of the Public Health Nurses has already been transferred from the station noted in this order, the officer in charge shall redirect the order to the new station where the incumbent is now working.

Those who have already enjoyed the 3<sup>rd</sup> time bound higher grade promotion shall not be allowed to relinquish their promotion. The date of joining and relieving should be reported promptly.

The incumbents are placed on probation for a period of one year actual duty within a continuous period of two year from the date of joining duty.

The whereabouts of rank numbers 485,548 and 555 were not received. Their promotions will be considered only after receiving the whereabouts and as per the availability of vacancies.
