ORDER

In the Annual Plan Budget 2018-19, an amount of **Rs. 50 Lakh** has been provided under the Head of Account '2210-01-110-48 (Plan)' for the implementation of the scheme '**Strengthening of Limb Fitting Centres**'. As per the letter read above the Director of Health Services has submitted Annual Plan Scheme proposal seeking administrative sanction for an amount of **₹ 50 Lakh** for implementing the above scheme by meeting expenditure from the provision under the above head of account, during 2018-19 and also requested sanction to distribute the amount to implementing officers through DMO (Health).

2. The Departmental Working Group Meeting for Health & Family Welfare Department held on 12.04.2018 scrutinised the above plan scheme proposal submitted by the Director of Health Services and approved as detailed in the minutes read above.

3. In pursuance of the decision of the Departmental Working Group, Administrative Sanction is accorded to the Director of Health Services for the purchase of equipments and materials for the manufacture of artificial limbs, calipers, braces, MCR chappals, etc. as part of the implementation of the scheme 'Strengthening of Limb Fitting Centres' at a total amount of **₹ 50** (Rupees Fifty Lakh only) by meeting the expenditure from the provision under the head of account '2210-01-110-48 (Plan)' during 2018-19 as detailed below. Sanction is also accorded to distribute the amount to implementing officers through DMO (Health) for implementation of the scheme.
