ORDER

In the annual plan budget 2018-19, an amount of **Rs. 800 Lakh** has been provided under the Head of Account '2210-05-105-36 (Plan)' for the implementation of the plan scheme 'Society for Rehabilitation of Cognitive and Communicative Disorders'. As per the letter read above the Director of Health Services has submitted Annual Plan Scheme proposal seeking administrative sanction for an amount of Rs. 800 Lakh by meeting expenditure under the above head of account for implementating the above scheme, during 2018-19 and also requested sanction to transfer credit the amount to ICCONS.

- 2. The Departmental Working Group Meeting for Health & Family Welfare Department held on 12.04.2018 scrutinised the above plan scheme proposal submitted by the Director of Health Services and approved as detailed in the minutes read above.

In pursuance of the decision of the Departmental Working Group, Government are pleased to accord Administrative Sanction to the Director of Health Services for implementing the scheme 'Society for Rehabilitation of Cognitive and Communicative Disorders' limiting the expenditure to the budget provision of Rs. 800 Lakh (Rupees Eight Crore only) by meeting the expenditure from the current year's budget provision under the head of account '2210-05-105-36 (Plan)'. Sanction is also accorded to transfer credit this amount to ICCONS for implementation of the programme.
