As per the minutes read as 1st paper above, it was decided to explore the possibility of setting up Cath Lab and CCU at Government Medicai College Hospital, Manjeri under Kerala Infrastructure Investment Fund Board (KIIFB) projects since there is space constrains and power augmentation issues in District Hospital Tirur.

(2) As per letter read as 2nd paper above, the Managing Director, Kerala Medical Services Corporation Limited (KMSCL) has informed that, the officials of KMSCL has visited Government Medical College, Manjeri and verified the availability of basic requirement for the installation of Cath Lab with CCU and has been confirmed that the proposed Cath Lab can be installed at Medical College, Manjeri and Cardiologist also available in the facility. The Managing Director, Kerala Medical Services Corporation Limited has requested to reallocate the installation of Cath Lab scheduled under KIIFB project from District Hospital Tirur, Malappuram District to Government Medical College Hospital Manjeri, Malappuram. As per the letter read as 3rd paper above, the General Secretary, Kerala Government Medical Officer's Association has informed that, it is not feasible to set up Cath Lab in Medical College, Manjeri due to non availability of Cardiology Department in the hospital and requested that the Cath Lab for Malappuram District may be re-allocated to General Hospital, Manjeri under the Health Service Department.

(3) Government have examined the matter in detailed and are pleased to accord sanction to re-allocate the installation of Cath Lab scheduled under KIIFB project from District Hospital Tirur, Malappuram District to General Hospital, Manjeri, Malappuram. The MD, KMSCL shall take further action in this regard.
