If any of the officers deputed have been transferred or promoted, the District Medical Officer of health concerned should inform the incumbents and Medical Officer in charge of the new institution about the posting without fail.

The Director of Medical Education is requested to issue necessary posting orders thereby relieving the incumbents in time and to make necessary arrangements for posting substitutes in case of absentees.
