ORDER

Dr.Jayasankar.N, Consultant (Orthopaedics), Pathanamthitta filed OA 372/17 before the Hon'ble KAT against G.O(Rt) No.421/2017/H&FWD dated 17.2.2017 wherein he was transferred from Distirct Hospital, Kozhenchery, Pathanamthitta and posted at General Hospital, Ernakulam vice Dr.Rajmohan transferred. The grievance of the medical officer was that he has to be retained at District Hospital, Kozhenchery itself and requested to quash the order read as 2nd paper above. The Hon'ble KAT in their order read as 3rd paper above directed Government to hear the applicant and consider and pass orders on Annexure A4 representation within 2 months from the date of receipt of a certified copy of the order.

2. The DHS, as per letter read as 6th paper above reported that, Dr.Jayasankar, Consultant (Ortho) has submitted a representation for reposting him at General Hospital, Alappuzha instead of General Hospital, Ernakulam if his request for retaining him at District Hospital, Kozhenchery is not considered. DHS has reported that one post of Consultant (ortho) at General Hospital, Alappuzha and Taluk Head Quarters Hosptal. Fort Kochi, Ernakulam are lying vacant.

3. Accordingly, along with the representation of the medical officers, a personal hearing was conducted by the Additional Secretary, H&FWD as ordered by the Hon'ble KAT. At the time of hearing, Dr.Jayasankar.N requested to retain him at District Hospital, Kozhenchery, Pathanamthitta. It is stated that

Dr.Reji Geroge, Consultant (Ortho) has been continuing at the District Hospital, Kozhenchery, Pathanamthitta for more than 8 years without any transfer. In the said circumstance his (petitioner's) transfer that too, within a period of one year from previous transfer is grossly unjust and discriminatory. He also stated that the post of Consultant (Ortho) was originally shifted from District Hospital, Kannur to District Hospital, Kozhenchery for the aforesaid Dr.Reji George and that his post is the one that is to be shifted back for administrative reasons, if any, and not the one that he holds.

4. The 4th respondent Dr.Rajmohan didn't appear for the hearing on 31.3.2017.

5. Government have examined the matter in detail and Dr.Reji Geroge has been at Kozhenchery for more than 8 years. It is unfair to let anyone have such a claim for a post. Dr.Reji George is posted at General Hospital, Alappuzha and Dr.Jayasankar.N is posted back to District Hospital, Kozhenchery, Pathanamthitta and the Order of Hon'ble KAT read as 3rd paper above in OA 372/2017 is complied with accordingly.


