ORDER

Dr.Anuja.V.G had been promoted and posted as Consultant (O&G) at District Hospital, Mananthavady vide G.O read as 1<sup>st</sup> paper above. Dr.Anuja.V.G, Consultant (O&G), District Hospital, Mananthavady filed OA 150/2017 before the KAT for posting her at Government Victoria Hospital, Kollam or at W&C Hospital, Alappuzha.

2. The Hon'ble KAT in their order dated 20.1.2017 directed Government to hear the applicant and to take a decision on her request within a period of six months from the date of receipt of order.

3.The DHS as per letter read as 3<sup>rd</sup> paper above reported that at present two vacancies exists at W&C Hospital, Alappuzha, wherein the applicant and another medical officer have requested for transfer. It was also intimated that none other than above two medical officers have applied for transfer to W&C Hospital, Alappuzha.

4.Accordingly, along with the representation of the medical officer, a personal hearing was conducted by Deputy Secretary, H&FWD as ordered by the Hon'ble KAT. At the time of hearing, Dr.Anuja V.G stated that at present there are 3 Consultants, 2 Junior Consultants and 1 Junior Consultant on working arrangement at District Hospital, Mananthavady in the respective speciality including her. She also stated that the present strength of cases can be managed by the remaining medical officers if she is transferred out. She requested for posting at Government Victoria Hospital, Kollam by transferring the present incumbent or at W&C Hospital, Alappuzha in the existing vacancy.

5.Government have examined the matter in detail and Dr.Anuja.V.G, Consultant (O&G), District Hospital, Mananthavady is transferred and posted as such at W&C Hospital, Alappuzha in the existing vacancy and the judgment of Hon'ble KAT, vide read as first paper above is complied with accordingly.
