**ORDER NO.EA1-67160/2016/DHS dated 08/12/2016**

As per the order read as 1<sup>st</sup> paper above, Government had granted permission to the Director of Health Services for provisionally appointing the Assistant Directors/ Civil Surgeons/ Assistant Surgeons who have Speciality qualification in the existing vacancies of Junior Consultants in the concerned Speciality in relaxation of the existing provisions in the Special Rules (Medical Officers) 2010 published vide G.O (P) No.69/2010// H&FW (A) Department dated 17/02/2010. The following Medical Officers who have specialty qualification are provisionally appointed as Junior Consultants under various specialties at the stations noted below, subject to the condition that they are not eligible for Speciality Cadre Seniority for the period of service they have rendered on provisional appointment. The appointment is purely on provisional basis in the existing vacancies of Junior Consultants till regular placement is given to them.
