ORDER

Dr. Christy. K, Junior Consultant (O & G) filed OA 1184/2017 before the Hon'ble Kerala Administrative Tribunal for suitable posting in Thiruvananthapuram district. She is working presently at Taluk Hospital, Wayanad and she, being a native of Thiruvananthapuram and due to retirement in 31/05/2019, requested for a posting in Thiruvananthapuram District, on compassionate grounds. The OA was filed requesting for a posting at Women and Children's Hospital, Thycaud, Thiruvananthapuram where existed a vacancy owing to the suspension of a Junior consultant(O&G). The Hon'ble KAT directed the First respondent to pass orders on her application within 4 months of receipt of order.

2. The Director of Health Services has reported that there existed one vacancy in W & C Hospital, Thycaud owing to the suspension of one Junior Consultant of Dr. Valsala and if Dr. Valsala was reinstated to the same hospital, then Dr. Christy cannot be considered. The Director of Health Services also reported that there exists no vacancy in any hospital in Thiruvananthapuram district

3. Government considered the matter in detail. The vacancy at W & C Hospital, Thycaud could not be considered in the case of Dr. Christy because Dr. Valsala, who had been on suspension earlier, had to be reinstated to the same hospital, on administrative reasons and so there exist no vacancy to consider Dr. Christy in that post.


4. Government also issued orders enhancing the retirement age of medical officers in Health Services Department from 56 to 60. That will enhance the applicant's retirement age also for another four years and so she

doesn't come under the purview of compassionate grounds for General Transfer
5. The Order dated 14/08/2017 in OA 1184/2017 filed by Dr. Christy. K, Junior Consultant (O & G) is thus complied with and ordered accordingly.
