ORDER

Dr.Jose C.V was on deputation for undergoing P.G Course from 09/07/2014 to 08/07/2016 during which time his contemporaries were given temporary promotion in their respective specialities as per G.O read as 1st paper above. Dr. Jose. C.V was not considered to the post since he was undergoing P.G course and no DPC have been convened to prepare a select list for promotion of Jr. Consultants to Consultants in O & G.

2. The Applicant was aggrieved that he was not granted promotion and posting on his return from studies, while many of his juniors were considered for temporary promotion and were given postings. So he filed OA (EKM) 2048/2017 before the Hon'ble Kerala Administrative Tribunal requesting to grant promotion.

3. The Hon'ble Kerala Administrative Tribunal while passing orders directed the 1st respondent (Govt.) to take a decision on his representation after hearing him, within a period of 2 months from 04/10/2017.

4. In another proposal dated 17/07/2017 from Director of Health Services, it was requested to grant temporary promotion to Dr. C.V. Jose as Consultant (O &G) and to post him at the vacant post in Women's & Children's Hospital, Mattanchery, soon after the Medical Officer rejoined service after completion of his P.G Course.

5. Government have examined the matter in detail. Dr. Jose. C.V was not considered in the promotion effected vide G.O read above, they were temporary promotions effected because of exigencies and since the Medical Officer was undergoing his P.G Course and hence, he could not be included then. Since the

proposal for preparing select lists to the post of Consultant (O &G) is under way and the Departmental Promotion Committee be convened on any time suitable to the members, the subject may wait till the Departmental Promotion Committee is over and the applicant be included in the select list, provided his credentials entitle him so.

6. The Order dated 20/09/2017 in OA (Ekm) filed by Dr. Jose. C.V is complied with.
