**ORDER**

Dr.Sheeba Dhas, Consultant (O &G) General Hospital, Pathanamthitta filed OA 1329/17 before Hon'ble Kerala Administrative Tribunal to post her as Consultant (O &G) at Women's & Child Hospital, Thycaud, Thiruvananthapuram wherein another person has also made a request for transfer against the same vacancy vide OA No. 2222/2016 before the Hon'ble Kerala Administrative Tribunal.

2. The Hon'ble Kerala Administrative Tribunal vide order read as 1<sup>st</sup> paper above instructed that the case of all the medical officers requesting for the vacancy in Womens's & Child Hospital, Thycaud has to be considered together along with other applications to the same post.

3. The Director of Health Services was requested to furnish proposal for considering for the vacancy at Women's & Child Hospital, Thycaud.

4. Government have examined the matter in detail. Dr. Sindhi. S, Taluk Head Quarters Hospital, Punnalur, Kollam was posted as Consultant at Women's & Child Hospital, Thycaud at existing vacancy during General Transfer as per Government Order read as 3<sup>rd</sup> paper. Director of Health Services vide 5<sup>th</sup> paper above has reported that Dr. Sindhi. S joined


duty on 21/08/2017 in Women's & Child's Hospital, Thycaud and also reported that there is no vacancy at present as Consultant Gynaecology in Women's & Child hospital, Thycaud. Hence the name of Dr. Sheeba Dhas cannot be considered and the judgment of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
