ORDER

As per Government Order read above Dr.Arul Prasad.S, Junior Consultant (Anaesthesia), W&C Hospital, Thycaud was promoted to the cadre of Consultant and posted at Taluk Hospital, Ranni, Pathanamthitta. But he has submitted a statement of relinquishment dated 05.03.2016, under Rule 38, KS&SSRs for relinquishing his promotion for a period of one year. He has also filed OA (EKM) 441/2016, praying a directive to the 2nd respondent Director of Health Services to consider and pass orders on Annexure A4 representation whereby he has requested to accept the relinquishment and allow him to continue in W&C Hospital, Thycaud.

2. In the order dated 17.03.2016, the Hon'ble KAT observed that Annexure A4 has been received by the 2nd respondent and Annexure A5 by the first respondent, Secretary. Hence it was directed to take a decision on Annexure A5, after hearing the applicant within a period of three months from the date of receipt of a certified copy of the order. It was also ordered to consider his request for posting in

Thiruvananthapuram and allow his relinquishment of promotion. Till then, the interim order directing not to relieve him from W&C Hospital will continue.

3. The applicant was heard and during hearing, he requested to accept his relinquishment as he is not in a position to leave Thiruvananthapuram District due to personal inconvenience. The Director of Health Services as per the letter read as 5th paper above has forwarded the statement of relinquishment for necessary action and orders.

4. The case is examined. Dr. Arul Prasad has requested for relinquishing his promotion to the cadre of Consultant for one year. The Accountant General as per letter read as 6th paper has certified that no Time Bound Higher Grade is sanctioned to the applicant.

5. In the above circumstances, Dr. Arul Prasad, Junior Consultant (Anaesthesia), W&C Hospital, Thiruvananthapuram is permitted to relinquish his promotion under Rule 38, KS&SSRs for a period of one year and permitted to continue at W&C Hospital, Thiruvananthapuram.

6. The Annexure A5 representation is disposed off as above and the direction of the Hon'ble KAT complied with accordingly.


