ORDER

As per the order read as 1st paper above, the Hon'ble Kerala Administrative Tribunal directed to consider and pass orders on Annexure A18 (representation from the applicant) and take appropriate decision on the request of the applicant for giving working arrangement as Civil Surgeon in Community Health Centre, Cherupa, Mavoor.

2) In the representation read as 2nd paper above the petitioner requested to give posting on working arrangement to CHC, Cherupa, Mavoor, Kozhikkode, in the existing vacancy of Civil Surgeon.

3)Government examined the matter in detail. The doctor is a Junior Consultant in Paediatrics and can therefore be posted only against the post of a Specialist. He has applied for working arrangement to a general cadre post. Hence he would be occupying the position of a Junior Consultant but doing the work of general cadre medical officer. This is a violation of rules and a waste of technical resources. Therefore it cannot be allowed.

4)In the above circumstances, Annexure A18 representation of the applicant cannot be considered and hence rejected. The order dated 15.02.2017 of the Hon'ble Kerala Administrative Tribunal in MA 265/17 in OA 2206 of 2016 is complied herewith.
