Government vide order 2nd cited above have granted permission to provisionally appoint Civil Surgeons/Assistant Surgeons who have speciality qualifications in the existing vacancies of Junior Consultant in relaxation of Kerala Health Services (Medical officers) Special Rules, 2010 published vide order read as 1st paper above.

In this circumstance, the following medical officers who have speciality qualification are provisionally appointed as Junior Consultant under various specialities subject to the condition that they are not eligible for Speciality Cadre seniority for the period of service they have rendered on provisional appointment. 
