ORDER

Dr.Leelamoney.S.Y, Senior Consultant (O&G) has filed OA No.1352/2016 requesting a directive to the respondents to post her in W&C Hospital, Thycaud, Thiruvananthapuram as she is the seniormost Gynaecologist in O&G and her junior Dr.Sam John Varghese was retained in W&C Hospital, Thycaud even after promotion.

2. Government as per the Order read as 3rd paper above complied the above Order of Hon'ble Kerala Administrative Tribunal directing Director of Health Services to consider the applicant's claim during General Transfer 2017 or within 3 months whichever was earlier. It is also ordered that the applicant could raise the issue further, if she did not qualify in the General Transfer. But Dr.Leelamoney.S.Y was not included in General Transfer 2017 as she had not completed 3 years service in her present station. Alleging against this Dr.Leelamoney filed CP(C) 193/2017 in OA 1352/2016.

3. The Advocate General vide letter 4th cited instructed the Government to pass appropriate orders on the applicants claim for being posted at Thiruvananthapuram.

4. Government examined the matter in detail and decided to temporarily accommodate Dr.Leelamoney.S.Y, Senior Consultant (O&G) in the post of Chief Consultant in Gynaecology at District Model Hospital, Peroorkada, Thiruvananthapuram for the time being as the post of Chief Consultant (O&G) is vacant in the State retaining her lien in her present post at General Hospital, Ernakulam.

5. The representation read as 2nd paper above is disposed of as above and the order of the Hon'ble Kerala Administrative Tribunal read above is thus finally complied with.
