ORDER

As per the Government Order read as 2<sup>nd</sup> paper above Government transferred Dr.Sindhi.S, Consultant (O&G), Taluk Hospital, Punalur, Kollam to Government Victoria Hospital, Kollam and Dr.Saraswathy Amma, Consultant (O&G), General Hospital, Adoor, Pathanamthitta to Taluk Hospital, Punalur, Kollam.

2. Against the transfer order Dr.Sindhi filed OA No.1133/2015 before the Hon'ble KAT and the KAT in their order read as 3<sup>rd</sup> paper above directed the first respondent (Secretary, Health & Family Welfare Department) in the OA to consider and pass orders on Annexure A9 representation read as 4<sup>th</sup> paper above in accordance with law after affording an opportunity of being heard to the applicant and the 3<sup>rd</sup> respondent within 3 months from the date of receipt of copy of the order.

3. The representative of the applicant was heard on 15.09.2015. At the time of hearing she submitted a statement pointing out that Dr.Sindhi is an inter-caste married person and hence the transfer is illegal and an unwarranted one. It is also

stated that her efforts resulted in the reduction of large number of C.Sections at Taluk Hospital, Punalur and hence requested to retain her at that station.

4. The third respondent in the OA Dr.Saraswathy Amma has already been retained in her previous station as per the Government Order read as 5<sup>th</sup> paper above.

5. In this regard Director of Health Services has submitted a proposal to Government to retain Dr.Sindhi,S, Consultant (O&G) at Taluk Hospital, Punalur and to transfer Dr.Mini.S.Nair, Consultant (O&G), W&C Hospital, Alappuzha to Government Victoria Hospital, Kollam.

6. Government have examined the matter. As the Medical Officer prefers to retain at Taluk Hospital, Punalur and the Director of Health Services also recommends for the same, Dr.Sindhi, Consultant (O&G) is retained at Taluk Hospital, Punalur. Dr.Mini.S.Nair, Consultant (O&G), W&C Hospital, Alappuzha who is now on working arrangement at Government Victoria Hospital, Kollam as per the Government Order read as 1<sup>st</sup> paper above is transferred and posted in the arising vacancy of Consultant (O&G) at Government Victoria Hospital, cancelling her working arrangement.

6. Annexure A9 representation of Dr.Sindhi is disposed of accordingly and the order of Kerala Administrative Tribunal in OA No.1133/2015 is thus complied with.
