Sub:- HSD – Speciality Cadre - Inviting options for placement of medical officers to speciality cadre who have undergone PG course under service quota and received deputation benefits and still continuing in Administrative/General Cadre – reg –

Govt. vide order referred 1st above (clause 11) have directed medical officers who have undergone PG course under service quota and availed deputation benefits to opt speciality cadre in which they have specialised. Those who have already received deputation benefits and have not opted to their specialities shall exercise the same within a period of one month from the date of issue of the above mentioned Government order; failing which their period of deputation will not be counted for service and pensionary benefits.

In this circumstance, it is directed that all medical officers who have already received deputation benefits and not opted to their specialities and still continuing in Administrative/General Cadre shall submit the options to speciality cadre in the prescribed proforma enclosed herewith through concerned District Medical Officers of Health. All medical officers submitting options shall enclose the self attested copy of certificates proving qualification, copy of TCMC Registration certificate and copy of order of

regularization of service and declaration of probation. Medical officers who have not successfully completed probation can also submit their options.

All District Medical Officers of Health shall collect the option forms submitted by the medical officers and forward the same so as to reach this office on or before 15th February 2018.

The names of those medical officers who fail to submit the same will be reported to Government and Accountant General (A&E), Kerala for further necessary actions stipulated in the Government Order referred 1st above.

Instructions

1. The medical officers shall read the Kerala Health Services (Medical Officers) Special Rules, 2010 and G.O.(P) No.106/2017/Fin dated.14.08.2017 before filling the option form.
2. The medical officers who are in service and acquired PG under service quota up to 31.12.2017 can submit option.
3. Self attested copies of certificates of Degree, PG Diploma/Degree, TCMC registration, order of declaration of probation, Order of regularisation of service shall be enclosed.
4. The Head of institution and DMO (H) concerned shall countersign the option form only after verifying the certificates of the applicant.
5. Options submitted without the signature of head of institution and countersignature of DMO (H) will summarily be rejected.
