ORDER

Dr.Lavannia Hameed.P.A, Junior Consultant (ENT), District Hospital, Palakkad filed OA 523/16 before the Hon'ble KAT for posting her as Consultant ENT at District Hospital, Palakkad. The grievance of the medical officer was that she was not given posting at Taluk Head Quarters Hospital, Chalakkudy, Thrissur after her promotion as Consultant vide G.O read as 2nd paper above. The Hon'ble KAT in their order dated 31.8.2016 directed Government to hear the applicant and the 3rd respondent (Dr.Elizabeth.T.Geroge, Consultant ENT, Taluk Head Quarters Hospital, Chalakkudy) and to take a decision on their request within 3 months from the date of receipt of order.

2. The DHS as per letter read as 3rd paper above reported that Dr.Lavannia Hameed.P.A, Junior Consultant was provisionally promoted to the post of Consultant and posted at District Hospital, Palakkad vide 2nd paper above. As it was a provisional promotion, her posting was subject to the availability of vacant posts and hence she was posted at District Hospital, Palakkad. Dr.Elizabeth.T.Geroge, Consultant (ENT) was given with reposting and hence general transfer norms were not applicable in this case.

3. Accordingly, along with the representation of the medical officers, a personal hearing was conducted by Deputy Secretary, Health & Family Welfare Department as ordered by the Hon'ble KAT. At the time of hearing, Dr.Lavannia Hameed stated that a retirement vacancy will occur in March due to the retirement

of Dr.Balachandran, Consultant and she requested to be considered for that post. Also, at present there is only one Junior Consultant post in Irinjalakkuda District Hospital. At present there is no vacancy of Consultant (ENT) in Thrissur district and so the applicant desires to be considered for working arrangement at General Hospital, Irinjalakkuda, due to her personal inconvenience.

4. Dr.Elizabeth.T.George was posted at District hospital, Kottayam as per G.O(Rt) No779/16/H&FWD/16/H&FWD dated 4.3.2016. At the time of publishing the G.O read as 2nd paper above, there was an open vacancy in Chalakudy hospital, but no one was posted in that Hospital and due to this reason she submitted request to be posted in that vacancy. She has been working there for 4 years as Junior Consultant. Dr.Lavannia Hameed.P.A is senior to Elizabeth.T.George. Since at present there are no posts available in the category of Consultant (ENT) in Thrissur district, Dr.Lavannia Hameed has requested for working arrangement at General Hospital; Irinjalakkuda.

5. Government have examined the matter in detail and orders that Dr.Lavannia Hameed.P.A is posted on working arrangement at General Hospital, Irinjalakkuda for a period of six months and the judgment of Hon'ble KAT vide read as first paper above is complied with accordingly.


