In the Annual Plan Budget for 2018-19, an amount of **Rs. 200 Lakh** has been provided under the head of account '2210-03-110-93 (Plan)' for the implementation of the plan scheme ‘Developing the Facilities of Hospitals and Health Care Institution in Tribal/Coastal and Remote Areas’. As per the letter read above, the Director of Health Services has submitted Annual Plan Scheme proposal seeking administrative sanction for implementing the above scheme for an amount of Rs.2,24,43,000/ by meeting the expenditure from the provision under the above head of account in the current year's budget.

2. The Departmental Working Group Meeting for Health & Family Welfare Department held on 30.05.2018 scrutinised the above plan scheme proposal submitted by the Director of Health Services and approved as detailed in the minutes read above.

In pursuance of the decision of the Departmental Working Group, Administrative Sanction is accorded for the construction of new building, PHC, Vellarikkundu, Kasaragode as part of the implementation of the scheme ‘Developing the Facilities of Hospitals and Health Care Institution in Tribal/Coastal and Remote Areas’ at a total cost of **Rs. 200 Lakh** (Rupees Two Crore only) by debiting the

expenditure from the provision under the head of account '2210-03-110-93 (Plan)', during 2018-19.

4. All the works shall be done in a transparent manner and in accordance with the prevailing norms and conditions.
