**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Administrative Sanction was accorded for Institute for Communicative and Cognitive Neurosciences (ICCONS) for the implementation of the scheme 'Society for Rehabilitation of Cognitive and Communicative Disorders ( SRCCD) at a total cost of Rs.800 Lakh by meeting expenditure from the current year's budget provision under the head of account 2210-05-105-36- 35 & 2210-05-105-36- 36 Grants for the creation of capital assets and Grant-in-aid General Non salary purpose (Plan). The Director, ICCONS, as per the letters read above, has requested to release the first instalment of the plan assistance under the head of account 2210-05-105-36- 35 & 2210-05-105-36- 36 (P) during 2018-19.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.250 lakh (Rupees Two hundred and fifty lakh only) from the provision under the head of account 2210-05-105-36-35-Grants for the creation of capital assets(P) and Rs. 160 lakhs (Rupees One hundred and sixty lakh only) from the provision under the head of account 2210-05-105-36-36-Grant-in-aid-General-Non Salary (P) as the first installment of plan allocation to Society for Rehabilitation of Cognitive and Communicative Disorders ( SRCCD) during 2018-19 for which Administrative Sanction accorded as per the Government Order read as 1<sup>st</sup> paper above, subject to the terms and conditions stipulated as per Government Order read as second paper above.

3. The Director of Health Services, Thiruvananthapuram will draw the amount and release the same to the Director, Institute for Communicative and Cognitive Neurosciences (ICCONS), Thiruvananthapuram.
