Sub : Health & Family Welfare Dept. - Nationwide National Health Resource Repository Census from 1st June 2018 to 31st March 2019 - reg

Ministry of Health and Family Welfare has taken-up a programme for establishing National Health Resource Repository (NHRR) for collecting and maintaining authentic, standardized and updated geospatial data of all public and private healthcare establishments in the country.

In this regard, a private agency namely IQVIA Consulting and Information Services India Private Limited has been engaged for nationwide data collection of all the private and public healthcare establishments and managing the execution of the programme. A copy of the advisory letter received from Secretary, MOIT-IFW is attached for reference.

The Office of Senior Regional Director of Ministry of Health and Family Welfare, Thiruvananthapuram has been assigned the responsibility of co-ordination of activities related to National Health Resource Repository in Kerala. In due course of time the selected agency namely, IQVIA or officers from the Office of Senior Regional Director, Ministry Of Health and Family Welfare may approach the public and private health institutions to collect the information.

The Heads of the Public health institutions and concerned associations of the private medical establishments are requested to advise their members to provide the required information for this National initiative.
