ORDER NO. EA2- 19693/2017/DHS Dated 02.05.2019

Dr. Nisha.P. Hari, Assistant Surgeon, Primary Health Centre Perumon, Kollam has transferred and posted to Community Health Centre Chadayamangalam, Kollam vide General Transfer order read as 1st above. She has filed an OA challenging her transfer before the Honourable Kerala Administrative Tribunal Thiruvananthapuram. Meanwhile her substitute Dr. Seema.K.T who has transferred from Community Health Centre Oachira, Kollam has assumed charge at Primary Health Centre Perumon, Kollam on the FN of 01.03.2019. Hari, Assistant Surgeon Primary Health Centre Perumon who stands transferred and posted to Community Health Centre Chadayamangalam, Kollam as per the order read 1st above is reposted to **Primary Health Centre Vellayani, Thiruvananthapuram** with immediate effect.

The order of the Honourable Kerala Administrative Tribunal is complied accordingly.


