ORDER NO. EA2- 19669/2019/DHS Dated 06.05.2019

As per the General Transfer order 2019 read as first above Dr. Saranya Babu.R, Assistant Surgeon Primary Health Centre Sakthikulangara, Kollam has transferred and posted to Taluk Head Quarters Hospital Punalur and Dr. John Mathew Assistant Surgeon Primary Health Centre Vellathooval, Idukki has posted in place of Dr. Saranya Babu.R, Primary Health Centre Sakthikulangara, Kollam.

Challenging to the above order Dr. Saranya Babu.R approached the Honourable Kerala Administrative Tribunal and the Honourable Kerala Administrative Tribunal stayed the operation and implementation of Annexure A3 as far as the applicant concerned for a period of one month as per order dated 05.03.2019. Dr. John Mathew her substitute has relieved from Primary Health Centre Velathooval, Idukki on 04.03.2019 has arrived at Primary Health Centre Sakthikulangara, Kollam on 06.03.2019. But he cannot be join duty there due to the interim stay order by the Honourable Kerala Administrative Tribunal. In obedience with the Honourable Kerala Administrative Tribunal Dr. John Mathew temporarily accommodate in a temporary leave vacancy at Leprosy Control Unit Kundara, Kollam.

The Honourable Kerala Administrative Tribunal order dated 05.03.2019 the stay extended for a period of one month and subsequently extended by two months on 04.04.2019. The Honourable Kerala Administrative Tribunal order dated 05.03.2019 it was directed that to the 2nd respondent to take a decision of the applicant to give a convenient posting or retention in the present station, with in a period of three weeks

from the date of receipt of copy of above order. The applicant has also directed to submit a copy of order along with a copy of the original application before the 2nd respondent. Accordingly Dr. Saranya Babu.R has furnished the same on 02.05.2019.

Above application have been examined in detail in accordance with law and General Transfer norms stipulated in Government order G.O(P) No.03/17/P&ARD dated 25.02.2017 and revealed that the retention of the incumbent is not in order. Dr. John Mathew her substitute posted to Primary Health Centre Sakthikulangara, Kollam has fully eligible for General Transfer to that station in all respect.

In the above context considering the request submit by Dr. Saranya Babu.R who stands posted to Taluk Hospital Punalur is reposted to **Primary Health Centre Perumon, Kollam** and Dr. John Mathew, Assistant Surgeon who has temporarily posted to Leprosy Control Unit Kundara, Kollam but as per the third reference above is reposted to Primary Health Centre Sakthikulangara, Kollam with immediate effect.

The direction of the Honourable Kerala Administrative Tribunal is complied accordingly.
