Praveen.J, Greeshmam, Kunnicode, Kollam -691508 who have been advised by the Kerala Public Service Commission as per their letter read above for appointment to the post of Assistant Dental Surgeon is temporarily appointed in the Health Services Department in the scale of pay of Rs.11910-19350 (Pre-Revised), under Rule 9(a)(i) of Kerala State and Subordinate Service Rules 1958, is posted to **Community Health Centre Cherpulassery, Palakkad** subject to the condition that his appointment shall be terminated without further notice if the appointing authority is not satisfied with his conduct and antecedents on subsequent verification. You shall be eligible for appointment in regular service in accordance with rules only if your character and antecedents are found satisfactory on subsequent verification. The appointment is also subject to Rule 3(C) of General Rules of Kerala State and subordinate Service Rules 1958.

The candidate is bound to work in rural areas as and when you are posted.

The candidate is directed to report for duty before the District Medical Officer of Health **Palakkad**, within **7** days on receipt of this order with relevant records in original to prove their qualification, Date of birth, Certificate of Registration with Travancore-Cochin Medical Council and Medical Certificate of Physical Fitness of Good Health obtained from a Medical Officer not below the rank of Civil Surgeon in Government Service (as per G.O(P) No.20/2011/P&ARD, Thiruvananthapuram dated 30/06/2011). The District Medical Officer of Health should verify the documents and also ensure the identity of the candidate before they are actually permitted to join duty in the respective institution to which the candidates are posted.

The candidate, who is now undergoing Post Graduate Studies, should execute a bond in person at the Directorate of Health Services after receiving the posting order, on stamp paper worth Rupees Two Hundred along with the original course certificate and continue with their higher studies. They should execute a bond to the effect that they will report for duty on the expiry of joining time and should serve the Government for a minimum period of 5 years after completion of the course, failing which an amount of Rs. 5 Lakhs (Rupees Five Lakh Only) will have to be remitted to Government. In case he does not join back, he shall be debarred from any further employment in Government Services and such names should be informed to Kerala Public Service Commission. Further, attested duplicated copy of the relevant documents may also be attached with the original documents.

The District Medical Officer of Health will obtain the enclosed attestation form duly filled up and signed by the candidates before they are allowed to join duty and forwarded to this office. The District Medical Officer of Health will also satisfy themselves about the identity of the candidate with reference to the photograph and signatures affixed thereon in the identification certificate, which is enclosed and the fact of having done so should be recorded on the identification certificate itself and the same forwarded to this office.

If the candidate is already employed in any other department, he may be permitted to join duty only after obtaining relieving order issued by the competent authority. Those Medical officers who are now working on contract / provisional basis should be terminated according to seniority when the Public Service Commission candidates join duty.

The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.

In the case of those candidates who fail to join duty within stipulated time, their appointment will be cancelled and the vacancy will be reported to Kerala Public Service Commission as 'Not Joining Duty.'
