In the Pay Revision Order read above, percentage based Higher Grade was sanctioned to Senior Superintendent/ Lay Secretary and Treasurer and Inter changeable posts as per special rules that is 25% of the total strength. Accordingly the strength of upgraded posts have been fixed as 36 Numbers. There are 22 employees now working in the cadre of Senior Superintendent/ Lay Secretary and Treasurer and Inter changeable posts as per special rules enjoying the percentage based higher grade.
