In the Pay Revision Order read above, percentage based Higher Grade was sanctioned to Senior Superintendent/ Lay Secretary and Treasurer and Inter changeable posts as per special rules that is 25% of the total strength. Accordingly the strength of upgraded posts have been fixed as 36 Numbers. There are 26 employees now working in the cadre of Senior Superintendent/ Lay Secretary and Treasurer and Inter changeable posts as per special rules enjoying the percentage based higher grade. As such 10 more officers in the above Cadre has to be sanctioned percentage based higher grade in the scale of pay of Rs. 40,500-85,000/- (Revised), the details are shown below.

The senior most officers holding rank number 79 to 91 vide reference 4th cited above are eligible for percentage based higher grade and out of this due to the retirement of officers rank number 85 and 88, the next two officers holding rank number 94 and 95 are also eligible for the same.

In the circumstances stated above, sanction is accorded to upgrade 10 posts of Senior Superintendent/ Lay secretary and Treasurer and Inter changeable posts as per special rules in the scale of pay of Rs. 40,500-85,000 (Revised) and the following senior most officers working in the cadre noted above are granted percentage based higher grade in the scale of Rs. 40,500-85,000 (Revised) with effect from the dates noted against their names.
