**ORDER NO.EE2-38607/2010/DHS/ DATED 08.10.2018**

The Honourable Kerala Administrative Tribunal vide Interim order read as 1<sup>st</sup> paper above have directed this respondent not to make any more by transfer appointment of Nursing Tutor for a period of 2 months without prior approval of the Tribunal and the interim order was extended from time to time and still in force.

Vide order read as 2<sup>nd</sup> paper above, the Honorable Kerala Administrative Tribunal have directed this respondent to consider and pass appropriate orders on Annexure A7 representation (representation filed by Smt. Bigi Punnoose, Head Nurse) in accordance with law within a period of 1 month from the date of receipt of a copy of the order. Accordingly, Smt. Bigi Punnoose was assigned Rank No. 77A-1 in the seniority list of Staff Nurse/ Head Nurse for the promotion to the cadre of Nursing Tutor vide order read 3<sup>rd</sup> above. In the seniority list of Staff Nurse/ Head Nurse for promotion to the cadre of Nursing Tutor incumbents up to Rank No.93 have been promoted to the cadre of Nursing Tutor vide this office order of even no. dated 09.08.2017. Since the juniors of Smt. Biji Punnoose were promoted, she was also promoted to the cadre vide order read 4<sup>th</sup> above when a vacancy arose without noticing the interim order read as 1<sup>st</sup> paper above.

Vide contempt petition read as 5<sup>th</sup> paper above Smt. Amala Rajan has filed contempt petition alleging disobedience of the direction of the Honourable Tribunal in the order read as 1<sup>st</sup> paper above.

Under the above circumstances, as it is revealed that there is substance in the allegation raised by the contempt petitioner, the promotion given to Smt. Bigi Punnoose to the cadre of Nursing Tutor without noticing the direction contained in the order read as 1<sup>st</sup> paper above is hereby cancelled.

The District Medical Officer (H), Pathanamthitta should give suitable posting to Smt. Biji Punnoose in the available vacancy of Head Nurse in Pathanamthitta district.
