As per orders read above, promotion of Pharmacist Gr-II to Gr-I was ordered and certain promotes were allotted to other districts to maintain prescribed ratio between Gr-I and Gr-II. Accordingly Pharmacist Gr-II, who has been promoted to Gr-I from Kollam district was retained in Kollam district and four pharmacist Gr-II were promoted as Pharmacist Gr-I from Thiruvananthapuram and allotted to Kollam district for want of vacancies in Thiruvananthapuram district, thereby the total of thirteen Pharmacists Gr-I was posted in Kollam district consequent on promotion.

As per order read (3) the ratio between Gr-II and Gr-I Pharmacist has been referred as 60:60 in Kollam district. At present, the total number of Gr-I Pharmacist in Kollam district is 60 and the total number of Gr-II is 61, consequent on promotion, which has exceeded the total sanctioned strength. Since no Pharmacist Gr-II can be transferred out from district as per rules, one Pharmacist Gr-II has to be accommodated against the post of Pharmacist Gr-I in order to maintain the total sanctioned strength in Kollam district.

In the above circumstances, the following pharmacist Gr-II who has been posted to Kollam district consequent on promotion is re-allotted to Pathanamthitta district as detailed below and one Pharmacist Gr-II is retained in Kollam district temporarily in the post of Pharmacist Gr-I so as to maintain the total strength.
