ORDER No.EE4/6552/2017/DHS, DATED:24/10/2018

In pursuance of Order read 8th, details and whereabouts of senior most 108 pharmacists Gr.II figuring in the Seniority list of Pharmacist Gr.II (upto the rank No.22 of 2009-2013) were collected and verified for promotion to the cadre of Pharmacist Gr.I.

2. Accordingly the Pharmacist Gr.II whose names are given in Annexure-1 of this order are promoted to the cadre of Pharmacist Gr.I in the pay scale of Rs.26500-56700 under Rule 31(a)(i) of KS&SSR with effect from the date of this order.
3. Some pharmacists who were included in the promotion list vide Order No.EE4/6552/2017/DHS. Dated:05/07/2018 have been found not eligible for promotion as they had availed Inter district transfer, thereby losing their original seniority. Their details are included in Annexure-II. District Medical Officer(Health) concerned may take necessary action for retaining them as Pharmacist Gr.II.
4. Details of Pharmacist Gr.I who are transferred to other districts, as per their request, are included at Annexure-III.

5. All DMOs(H) concerned are directed to issue suitable posting orders to the incumbents. The head of institutions are directed to relieve the incumbents after getting suitable posting from DMOs(H) concerned.

6. The promotees are bound to work in any institution across the state since the post of Pharmacist Gr-I is in the State –wise cadre. No preferential claim will be given to Pharmacist Gr-I employees for transfer to other District /station. If any of the promotees comes under the purview of Inter District/Inter Departmental transfer, their future seniority will be governed under the provision in Govt Order vide 5,6& 7 read above.

7. Before permitting the promotees to join in the higher post (Pharmacist Gr-I), the Heads of Office should confirm their rank number, name, date of birth and district /present station. If any employee is promoted in this order due to faulty whereabouts furnished by the DMOs(H) and who are not in service now (LWA/suspension etc) or any of them have already been promoted as Pharmacist Gr-I, such employees will automatically be deleted from Annexure-I of this Order.

8. All District Medical Officers(Health) are directed to ensure 1:1 ratio between Pharmacist Gr-I and Pharmacist Gr-II in their Districts concerned. Any disparity in this regard should be reported to this office at the earliest. In future the ratio between Pharmacist Gr-I and Pharmacist Gr-II in District level should be strictly maintained as 1:1.

9. The promotees are directed to submit three copies of the joining report in the prescribed Proforma to Head of Office concerned. After making necessary entries in their Service Books, the Head of Office should forward two copies of the joining report to the DMO(H) concerned and DMO(H) should forward a copy of the joining report to DHS alongwith the countersignature for confirming their promotion in the cadre of Pharmacist Gr-I. All DMO(H) /Head of Office should maintain separate cadre register of Pharmacist Gr-I & Gr-II on the basis of joining report of promotees in the higher cadre.

10. The following employees are excluded from the promotion order:

- a) Those employees who have opted medical education service and included in common seniority list and now working under Directorate of Medical Education.
- b) Those employees whose whereabouts are not available.

- c) Those employees who are not in service(LWA/suspension etc.)
 - d) Those employees who are included in seniority list with erroneous rank position.
 - e) Employees included in seniority list but availed IDT before effecting promotion
 - f) Those employees facing disciplinary action
11. Those incumbents who are left out from this order for want of whereabouts, may submit appeal with documents to prove their claim through proper channel within 10 days from the date of this order. The Head of Institution/DMOs(H) should verify their claim before forwarding the appeals to this office.
12. Any discrepancy in this order should be brought to notice of the undersigned within 10 days from the date of this order through DMO(H) for necessary correction.
13. All DMOs(H)/Heads of Office/promoted employees are permitted to use the printout of this order published in the official website of DHS for official website of DHS for official purpose.




