As per the order read 1st above, the Staff Nurse Grade II whose seniority position was reassigned after the abolition of dual control system were given promotion to the cadre of Staff Nurse Grade I. The Staff Nurses who were left out from the above promotion order for want of whereabouts and those who were on leave during the period of promotion and rejoined subsequently are promoted to the cadre of Staff Nurse Grade I in the scale of pay of Rs. 29200-62400 and allotted to the districts mentioned against their names as detailed in Annexure A&B respectively.

The Staff Nurses who were promoted erroneously during the currency of leave vide various orders are hereby reviewed and reassigned as detailed in Annexure C. The earlier promotions awarded to the incumbents included in Annexure C stands cancelled.

The serial numbers 53, 54, 55, 57, 59 and 60 in the promotion order read 1st above, were transferred out from Kollam for want of vacancies and were posted to Thiruvananthapuram District. Consequent on occurrence of vacancy in Kollam district, the above Staff Nurses are re-allotted to Kollam district in the existing vacancy.
