In Health Service Department the ratio of Laboratory Technician Gr-I and Gr-II was fixed as 1:1 by the order read as 4th above. But in many districts the ratio could not be maintained proportionately due to excess of Laboratory Technician either in Gr-I or Gr.II categories. In this situation the ratio of Laboratory Technician Gr.I and Gr.II can only gradually be maintained.

As per the report from District Medical Officers of Health the total sanctioned strength of Laboratory Technicians and the present in position strength and vacancy of Laboratory Technicians Gr.I and Gr.II in each district are placed below.

As per the order read 3rd paper above 102 Laboratory Technicians Gr.II were given ratio promotion as Gr.I from the seniority list from 01-01-2011 to 31-12-2016. Now the following Laboratory Technician Gr.II who were included in the seniority list published vide the order read 1st and 2nd cited and those who had completed the probation successfully are granted ratio promotion as Laboratory Technician Gr.I in the scale of pay of Rs. (26500 – 56700) and allotted to the District Medical Officers of Health for suitable postings. The incumbents who have been promoted and retained in the present district can be allowed to continue in the present station if the institution wise post of Lab Technician Gr.I and Gr.II was not fixed. If the promotees are retained in the present station it will be reviewed during future General Transfer if required. The list of the promotees are appended with this order.

The District Medical Officer of Health concerned should verify the name, rank no. , Date of Birth and the date of declaration of probation of the incumbents in the promoted list before effecting promotion. The District Medical officers should also verify whether there is any disciplinary action is pending against the promoted hands and if so these incumbents should not be promoted and this fact should be reported to this office immediately. If any of the incumbents has been transferred from the station noted in this order, the head of institution concerned shall redirect the order to the new station in where the incumbent is now working

The Head of institution should relieve the incumbents only after getting posting orders from the District Medical Officer of Health Concerned. The Head of Institution should enter the details of promotion in their service book when they join duty in the promoted cadre. The promotees who were not acquired 1st Time Bound Higher Grade are eligible for fixation under rule 28 A part – I of K.S.R. as per the provisions laid in the Pay Revision Order vide G.O.(P) No.7/2016/ Fin Dated 20-01-2016. Those who had already enjoyed grade promotion shall not be allowed for relinquishment of promotion

The Rank No.62 (A) in the seniority list has submitted declaration for relinquishment of promotion as such she was not promoted. The probation of rank nos.142,186(A), 186(B), 200, 201, 203,204,210,213,214,217 and 218 were not declared as such they were excluded from the list. The whereabouts of rank.nos.164, 196, and 202 were not received. Their promotions will be considered only after receiving their whereabouts and probationary status and considering the vacancies. If any discrepancy in this order is noted it should be reported to this office within 15 days through proper channel with supporting documents to substantiate their claims.

The date of relieving and joining duty should be reported promptly
