

**PROCEEDINGS OF THE DEPUTY DIRECTOR OF HEALTH SERVICES

Sub: HSD - Estt. - Refixation of ratio among Senior Grade Dental Mechanic, Dental Mechanic Gr. I and Dental Mechanic Gr. II and ratio based promotion to the cadre of Senior Grade Dental Mechanic and Dental Mechanic Gr. I - Orders issued.

As per order read 1<sup>st</sup> above, the ratio of Senior grade Dental Mechanic, Dental Mechanic Grade I and Dental Mechanic Grade II was fixed considering the number of posts existed as on 17.07.2014 since then 25 posts of Dental Mechanic Gr. II have been created vide Government order read 3<sup>rd</sup> above.

In this circumstances, in order to maintain the ratio 1:2:2 among Senior grade Dental Mechanic, Dental Mechanic Gr. I and Dental Mechanic Gr. II, the strength among these categories are hereby refixed as follows.

Total No. of Posts	- 58
Senior Grade Dental Mechanic	- 11
Dental Mechanic Gr.I	- 23
Dental Mechanic Gr.II	- 24

The fixation of ratio will take effect from 23-09-2017.

Consequent on the refixation, the following Senior most Dental Mechanic Gr.I are promoted as Senior grade Dental Mechanic in the scale of pay Rs. 27800-59400 and the incumbents are allowed to continue in their present stations.
