S. R. O. No. 805/2017.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) and in supersession of all the existing orders on the subject, the Government of Kerala, hereby make the following Special Rules for the Kerala Public Health Subordinate Service, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Public Health Subordinate Service Special Rules, 2017.

(2) They shall come into force at once.

2. *Constitution.*—The service shall consist of the following categories, namely:—

- Category 1 .. Health Supervisor/Health Inspector Grade I/Filaria Inspector Grade I/Malaria Inspector Grade I.
- Category 2 .. Health Inspector Grade II/Filaria Inspector Grade II/Malaria Inspector Grade II.
- Category 3 .. Junior Health Inspector Grade I/Evaluation Assistant.
- Category 4 (A) .. Junior Health Inspector Grade II.
- (B) .. Field Assistant/Insect Collector.

3. *Method of Appointment.*—Appointment to the various categories mentioned in column (1) of the Table below shall be made by the method of appointment specified against each in column (2) thereof, namely:—

'by transfer' appointment. A ratio of 1:3 is fixed for by transfer appointment and direct recruitment. A ratio of 2:2:1 is fixed for 'by transfer' appointment feeder categories of :

- (a) Office Attendant/ Watchman
- (b) Field Workers
- (c) By transfer appointment to the category 4 (A) shall be made from the other feeder categories by preparing a seniority list exclusively for this category (such as Theatre Assistant, Projectionist, Binder, Store Keeper, Power House Mechanic, Electric Welder, Electric Mechanic, Head Cook, Cinema Operator, Theatre Attendant, House Keeper, Laboratory Assistant, Packer, Nursing Assistant, Dresser, Messenger, Lift Attendant, Phone Attender,

3. *Registration* Registration with Kerala Paramedical Council.

Note:—Those who are working in the feeder categories can apply for 'by transfer' appointment. They will be eligible for 'by transfer' appointment in accordance with existing rules. A ratio of 1:3 is fixed for by transfer appointment and direct recruitment. A ratio of 2:2:1 is fixed for 'by transfer' appointment from:

(a) Office Attendant/
Watchman

(b) Field Workers

(c) Other feeder categories, such as Theatre Assistant, Projectionist, Binder, Store Keeper, Power House Mechanic, Electric Welder, Electric Mechanic, Head Cook, Cinema Operator, Theatre Attendant, House Keeper, Laboratory Assistant, Packer, Nursing Assistant, Dresser, Messenger, Lift Attendant, Phone Attender, Stable Attendant, Attender of all categories, Hospital Attendant Grade I, Hospital Attendant Grade II, Helper, Bottle Cleaner.

Note:—1. Existing employees having 5 years service with SSLC and Health Inspector Course/Sanitary Inspector Course are exempted from passing Plus 2/VHSE or its equivalent and Diploma in Health Inspector Course.

2. The employees in feeder categories who are in Government Service as on 8th July, 2008 and working in Health Services Department as on 31st December, 2010 are exempted from passing Diploma in Health Inspector Course and Plus 2.

(A) Field Assistant/
Insect Collector

By promotion from the category of Field Worker

1. *General*

Pass in Plus 2 with Science subjects or its equivalent examination from an institution recognized by Government of Kerala.

2. *Technical*

Diploma in Health Inspector Course conducted by Director of Health Services or by any other Institution recognized by Government of Kerala.

Note:—Existing Field Workers having 5 years service and SSLC with Multi Purpose Workers Training/Health Inspector Course/Sanitary Inspector Course are exempted from passing Plus 2/VHSE or its equivalent and Diploma in Health Inspector Course.

Note:—No provision under this rule shall affect the selection or advice of the candidates already made by the Public Service Commission and to be made in response to the notification issued by the Commission prior to the date of effect of these Rules.

5. *Age limit.*—No person shall be eligible for appointment by direct recruitment to the entry post if he has not completed 18 years of age and has completed 36 years of age as on the 1st day of January of the year in which application for appointment are invited with usual relaxation admissible to candidates belonging to Scheduled Castes/Scheduled Tribes and Other Backward Classes.

6. *Appointing Authority.*—The Director of Health Services shall be the appointing authority in respect of the categories 1 to 3 and the District Medical Officer of Health Department concerned shall be the appointing authority in respect of category 4. For appointment by transfer from the feeder categories, the Director of Health Services shall be the appointing authority.

7. *Reservation of Appointment.*—The Rules regarding reservation of appointments (General Rules 14 to 17 in part II of the Kerala State and Subordinate Service Rules, 1958) shall apply to the appointments by direct recruitment.

8. *Probation.*—Every person appointed to any of the categories shall be from the date on which he joins duty be on probation:—

(a) if appointed by direct recruitment/by transfer from feeder categories, for a total period of two years on duty within a continuous period of three years, and

(b) if appointed by promotion, for a period of one year on duty within a continuous period of two years.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In order to widen the knowledge of the public health personnel and to equip them to face the changing situations effectively, it has become necessary to revise the qualification and method of appointment to various posts in the Kerala Health (Public Health Wing) Service. Since the Special Rule for the Kerala Health (Public Health Wing) Service have not been issued so far Government have decided to issue the Special Rules for the posts included in the service in supersession of all the existing orders.
