As per letters referred 1st & 2nd cited, 2 Nursing Staff have been submitted appeals for including their name in the seniority list of Staff Nurse Gr.II (1990-2002) & Staff Nurse Grade-II (2003-2010). The grievances raised in the above said appeals have been examined in detail with all connected service details and found certain anomalies. While verifying the list of Staff Nurse GrII (1990-2002). It is noticed that the rank no's 3762 B to F which have been awarded to the incumbents erroneously without considering the PSC advice seniority.

Accordingly vide paper read as 3rd above, a notice has been issued from this office intimating the provisional decision to rectify the anomalies occurred in the seniority list and also inviting appeals if any regarding the same. No genuine appeals have been received in this regard.

In these circumstances, it is provisionally decided to rectify the anomalies occurred in the said seniority lists as detailed in the Annexure 'A' appended herewith.
