**ORDER No. ES3-6911/2017/DHS dated 15/12/2018**

The final seniority list of Staff Nurse Gr.I from 10/11/2008 to 20/8/2013 was published vide order read as first above. In continuation to the above, the preliminary seniority list of Staff Nurse Grade.I in this Department for the period from 21/08/2013 to 31/12/2016 was published vide order read 5<sup>th</sup> and inviting appeals from aggrieved parties regarding any corrections/anomalies etc. The appeals received in this regard have been scrutinized and after incorporating necessary amendments based on the appeals deserving merit, the 2<sup>nd</sup> preliminary list was published vide the notice read 6<sup>th</sup> above.

As per GO (Rt) No.3554/17/H&FWD dated,18/12/2017 & GO (Rt) No. 3606/17/H&FWD dated, 22/12/2017, Government have accorded sanction to reassign the seniority position with effect from the date of PSC advice of those Staff Nurses, who were transferred out of their respective recruited districts, consequent of abolition of dual control system. Accordingly, based on their requests, their seniority position was fixed with effect from the date of their PSC advice and they were placed in appropriate position as per merit in the seniority list of Staff Nurse Gr.II for the period from 01/01/2003 to 30/06/2010 vide this office order No.ES3-20120/17/DHS dated, 26/4/2018.

The Honorable Kerala Administrative Tribunal have issued an order on 10<sup>th</sup> July 2018 in OA No.1188/2018 filed by Smt.Suma.VK and others that “the eligible among the applicants are given due promotion as Staff Nurse Gr.I and that they are included in the final seniority list of Staff Nurse Gr.I in accordance with the assigned dates of their promotions”. Eligible Staff Nurse Gr.II those who are included in the seniority list of

Staff Nurse Gr.II have been promoted as Staff Nurse Gr.I as per order 8<sup>th</sup> above and they have been included in the final seniority list of Staff Nurse Gr.I for the period from 21/08/2013 to 31/12/2016. The direction of Hon'ble Kerala Administrative Tribunal in the order dated, 10/07/2018 in OA No.1188/2018 has complied with accordingly.

The final seniority list of Staff Nurse Grade.I in this Department for the period from 21/08/2013 to 31/12/2016 is published herewith as detailed in **Annexure-A** appended. This seniority list consists of the incumbents from rank No.3460 to 3895(1990-2002 Staff Nurse Gr.II seniority list) & Rank No.1 to 2800 (2003-2010 Staff Nurse Gr.II seniority list) and who have been promoted to the cadre of Staff Nurse Gr.I between the period from 21/08/2013 to 31/12/2016. Those incumbents who have already left this Department and joined Medical Education Service consequent on abolition of Dual Control System have been excluded.

In respect of incumbents who joined as Staff Nurse Gr.I consequent on order read 2<sup>nd</sup> to 4<sup>th</sup>, their seniority has been arranged in the order of their seniority position in the cadre of Staff Nurse Gr.II. In respect of the incumbents who were on LWA during the issuance of order read 2<sup>nd</sup> to 4<sup>th</sup> and rejoined duty further between the period from 21/08/2013 to 31/12/2016, their seniority has been arranged from the date of their rejoining duty after LWA assigning the rejoining date as date eligible for promotion.
