The Pharmacist Grade II whose names are given in Annexure I of this order are promoted to the cadre of Pharmacist Grade I in the pay scale of Rs.26500-56700 under Rule 31 (a) (i) of KS&SSR with effect from the date of this order.

Details of Pharmacist Grade I who is transferred to other district as per her request is included at Annexure II.

All District Medical Officers of Health concerned are directed to issue suitable posting orders to the incumbents. The head of institutions are directed to relieve the incumbents after getting suitable posting from the District Medical Officers of Health concerned.

The promotees are bound to work in any institution across the state since the post of Pharmacist Grade I is in the state wise cadre. If any of the promotees comes under the purview of inter district / inter departmental transfer, their future seniority will be governed under the provision in Government order vide 4,5 and 6 read above.

Before permitting the promotees to join in the higher post (Pharmacist Grade I) the head of office should confirm their rank number, name, date of birth and present station. If any employee is promoted in this order due to faulty whereabouts furnished by District Medical Officers of Health, who are not in service now (LWA/Suspension) or have already been promoted as Pharmacist Grade I, such employees will automatically be deleted from Annexure I of this order.

The promotees are directed to submit three copies of joining report in the prescribed proforma to head of office concerned. After making necessary entries in Service Books the head of office should forward two copies of the joining report to District Medical Officer of Health concerned and District Medical Officer of Health should forward a copy of joining report to Director of Health Services along with the counter signature for confirming their promotion in the cadre of Pharmacist Grade I. All District Medical Officers of Health / Health of Office /promoted employees are permitted to use print out of this order published in the official website of DHS for official purpose.


