Subsequently Dr. Manoj.K.M, Assistant Surgeon who was posted at Community Health Centre Koduvally, Kozhikode in General Transfer 2018 is transferred and posted to Primary Health Centre Peruvayal Kozhikode in the existing vacancy as per the facts in hearing.

The order of Honourable Kerala Administrative Tribunal dated 04.09.2018 in OA No. 1676/18 filed by Dr. Rincy Antony, Assistant Surgeon read as 1st above is complied accordingly.
