The Final seniority list of LD Clerks during the periods 1986-90, 1990-93, 1994-97, 1997-02, 2003-08 were published vide papers read as 1st to 5th above respectively.

The Preliminary seniority list of Senior Clerks, who were promoted as Senior Clerk during the period from 17/06/2000 to 31/12/2012, has been published vide order read as 6th above. Certain appeals have been received regarding assignment of seniority in the cadre of LD Clerks. On verification of the service particulars, it is noticed that the rank no of 25 incumbents, who were included in various seniority lists of LD clerks during the period from 1986 to 2008, are seen wrongly assigned and promoted to the cadre of UD Clerk on the basis of this wrong seniority position. It is found that the seniority of the above candidates in the cadre of LDC are assigned without following the rules stipulated in the GOs read as 7 to 11 above.

In this circumstance, it is provisionally decided to reassign the rank No of the 25 incumbents in accordance with the rules stipulated in the GOs read as 8 to 11

above as detailed in **Annexure A** appended herewith. The promotion given to the above incumbents to the cadre of UD Clerks will also be re-examined after finalizing the proposal and the seniority in the cadre of UDC will be fixed accordingly.

Those who aggrieved of the proposal shall file appeals, in the prescribed proforma attached herewith with proof to substantiate their claim through their head of institution on or before 5/8/2014. Those who are aggrieved and want to hear in person are directed to attend the hearing which is proposed to conduct at 11AM on 5/8/2014 in the chamber of Senior Administrative Officer of DHS Office.
