The Final Seniority List of Pharmacist Grade-II for the period from 1/1/1978 to 14/12/1990 had been published vide this office order read as 1st paper above.

Certain Officers included in the list have challenged the seniority assigned to the persons who secured Inter District Transfer and availed Leave Without Allowances etc. The Hon'ble High Court of Kerala, vide Judgement read as 2nd paper above, has issued direction to consider representations submitted by petitioners. Accordingly, Government had given sanction to revise the seniority list of Pharmacist for the period from 1/1/1978 to 14/12/1990, as per the G.O. read as 3rd paper above.

As such, the service details of the Pharmacist, who entered in service for the above period, have been collected from all the District Medical Officers of Health again. On verification of the service records it is found that certain incumbents were given seniority without considering the Inter District Transfer/Leave without Allowances secured by them.

Accordingly, the seniority assigned earlier to those persons, who availed Inter District Transfer and Leave Without Allowances up to 14/12/1990 has been reassigned and a Revised Final seniority list was published vide this office read as 4th paper above, after giving opportunities to the aggrieved persons for submitting appeals, if any. On the basis of the Revised Final seniority list of Pharmacist Gr II for the period from 1978-1990, the seniority list of Pharmacist Store Keeper for the period from 1/1/2008 to 31/12/2010 was also revised vide this office order No ES3- 89444/12 DHS dated 18/01/2013.

While so, Sri. Kallyanakrishnan & 6 others and Smt Jaimol filed WP(c) No 34050/11 and WP(c) No 33808/11 respectively before the Hon'ble High Court against the revised final seniority list. The Hon'ble Kerala Administrative Tribunal in their joint order read as 5th paper above quashed the Annexure A22 i.e. G.O read as 3rd above and directed the Government to reconsider whether the seniority in Annexure A2 i.e. seniority list of Pharmacist Gr II for the period from 1/1/1978 to 14/12/1990 should be permitted to be disturbed after affording an opportunity of being heard to the applicants and other affected parties within three months from the date of receipt of the copy of the order.

Accordingly Government, vide order read as 6th paper above, directed the Director of Health Services to prepare a revised seniority list of Pharmacist Gr II for the period from 1/1/1978 to 14/12/1990 after seeking appeals if any from all affected parties, after observing all formalities for revision of seniority list and submit a consolidated proposal to Government for approval of the same.

In these circumstances, a Revised Preliminary seniority list of Pharmacist Gr II for the period from 1/1/1978 to 14/12/1990 is prepared after observing all rules stipulated in Rule 27 in KS & SSR and relevant orders.

Those who are aggrieved of the ranks assigned, whose name found missing or found any incorrect service details shall file appeals, if any, in the prescribed proforma attached herewith with proof to substantiate their claim within 30 days from the date of this order.

The aggrieved persons can also attend the hearing, which is proposed to conduct at 11 AM on 22/07/2014 in the chamber of Additional Director of Health Services (Medical) of DHS Office with all connected documents to substantiate their claim.

The District Medical Officer of Health concerned will circulate the copy of this list among all concerned under their control.
