The candidate is directed to report for duty before the District Medical Officer of Health concerned within 05 days on publishing of the posting orders failing which action will be taken to cancel the appointment. The candidate should produce the original certificates:-

1. to prove Educational Qualification, Date of birth, Identity for verification.
2. Certificate of Physical Fitness obtained from a Medical Officer in Government service not below the rank of Civil Surgeon/Consultant.
3. Original Non-Creamylayer Certificate

The District Medical Officer of Health should verify the above documents before permitting the candidates to join duty.

The appointment of the candidate is subject to Rule 3(C) of the General Rules of the KS &SSR 1958. The appointment is purely provisional and the candidate is eligible for appointment in regular service only if the character and antecedents are found satisfactory on further verification. Her appointment shall be terminated without, further notice, if the appointing authority is not satisfied with her conduct and antecedents on subsequent verification.

If there is any discrepancy found, the candidate should not be allowed to join duty and the fact should be reported to this office forthwith. After the candidate is allowed to join duty, the copy of identification certificates may be kept pasted in the service book.

The service book will be opened within one week from the date joining duty and attested photocopy of the page containing name, address, Finger Print, Identification marks and qualification should be forwarded to this office along with Appendix I received from the candidate for PSC & Police verification. The appointment shall be regularized only after the receipt of verification certificate from KPSC and Police authorities.

The application for correction of date of birth, if any required should be made by the candidates within five years from the date of entry in service.

No separate appointment order is sent to the candidates. Hence she is requested to download the appointment order from the website www.dhskerala.gov.in.

The posting will be reviewed during General Transfer 2020 if necessary.
