COVID-19 – ADDENDUM TO THE ADVISORY FOR QUARANTINE AND TESTING OF PRISONERS WHO ARE NEWLY INCARCERATED OR RETURNING TO JAIL AFTER PAROLE

- World Health organisation has declared COVID-19 as a pandemic.
 Kerala has been taking all measures to contain the outbreak through strict surveillance and infection control measures.
- 2. In order to ensure there is no spread of COVID19 in Jails, the guidelines issued as per the Advisory dated 20th May 2020. The Department of Home has issued the GO (Rt) 1193/2020/AG dated 20th May 2020.
- 3. In order to further streamline the arrangements for the prisoners the following addendum to the advisory dated 20th May 2020 is issued.
- A. All District will designate one nodal officer to liaison with officers with respect to the Prisoners.
- B. All District will identify one COVID First Line Treatment Centre (CFLTC) for the following purposes
 - a. The Prisoners who are waiting for the RTPCR test results should be accommodated in CFLTC.
 Once their result is available and declared NEGATIVE, they will be shifted to the respective Prisons
 - b. The Prisoners who are POSTIVE and having no symptoms shall be kept in CFLTC. Such prisoner's symptom surveillance shall be done on daily basis.
 - c. The Prisoners who are POSITIVE and developing any symptoms to be shifted to COVID Hospital.

C. DGP Department of Prisons and correctional services shall provide security to the CFLTCs and COVID Hospitals.

The Copy of the CFLTC and Designated Officers of the Department of Health to liaison with Department of Prisoners and correctional services is attached.
